We take a proactive approach to user privacy and ensure that necessary steps are taken to protect the privacy policy of the users through their visiting experience.

We are working to earn your trust every day by focusing on six key privacy principles:

Control: We will put you in control of your privacy with easy-to-use tools and clear choices.

Transparency: We will be transparent about data collection and use so you can make informed decisions.

Security: We will protect the data you entrust to us through strong security and encryption.

Strong legal protections: We will respect your local privacy laws and fight for legal protection of your privacy as a fundamental human right.

No content-based targeting: We will not use your email, chat, files or other personal content to target ads to you.

Benefits to you: The collect data will be used for your benefit only and to make our services better which will always have oriented to make your experiences better.

We are committed to protect your privacy. Authorized employees within ourselves, on a need to know basis only, use any information collected from individual users. We constantly review our systems and data to ensure the best possible service to our users. We will adhere by the laws in place that create offences for unauthorized actions against computer systems and data. We will investigate any such actions with a view to prosecuting and/or taking civil proceedings to recover damages against those responsible.

We've tried to keep it as simple as possible. Your privacy matters to Parijat, so whether you are new to Parijat or a long-time user, please do take the time to get to know our practices.

Transparency and choice

People have different privacy concerns. Our goal is to be clear about what information we collect, so that you can make meaningful choices about how it is used.

Accessing and updating your personal information

Whenever you access our Web, we aim to provide you with access to your personal information. If that information is wrong, we strive to give you ways to update it quickly or to delete it – unless we have to keep that information for legitimate business or legal purposes. When updating your personal information, we may ask you to verify your identity before we can act on your request.

We may reject requests that are unreasonably repetitive, require disproportionate technical effort (for example, developing a new system or fundamentally changing an existing practice), risk the privacy of others, or would be extremely impractical (for instance, requests concerning information residing on backup systems).

Where we can provide information access and correction, we will do so free of charge, except where it would require a disproportionate effort. We aim to maintain our services in a manner that protects information from accidental or malicious destruction. Because of this, after you delete information from our services, we may not immediately delete residual copies from our active servers and may not remove information from our backup systems.

Information that we share

We do not share personal information with companies, organizations and individuals outside of Parijat unless one of the following circumstances applies:

With your consent

We will share personal information with companies, organizations or individuals outside Parijat when we have your consent to do so. We require opt-in consent for the sharing of any sensitive personal information.

For external processing

We provide personal information to our affiliates or other trusted businesses or persons to process it for us, based on our instructions and in compliance with our Privacy Policy and any other appropriate confidentiality and security measures.

• For legal reasons

We will share personal information with companies, organizations or individuals outside Parijat if we have a belief in good faith that access, use, preservation or disclosure of the information is reasonably necessary to:

- meet any applicable law, regulation, legal process or enforceable governmental request.
- o enforce applicable Terms of Service, including investigation of potential violations.
- o detect, prevent or otherwise address fraud, security or technical issues.
- protect against harm to the rights, property or safety of Parijat, our users or the public, as required or permitted by law.

If Parijat is involved in a merger, acquisition or asset sale, we will continue to ensure the confidentiality of any personal information and give affected users notice before personal information is transferred or becomes subject to a different privacy policy.

Information security

We work hard to protect Parijat and our users from unauthorized access to or unauthorized alteration, disclosure or destruction of information that we hold.

When this Privacy Policy applies

Our Privacy Policy applies when you access our Web.

Compliance and cooperation with regulatory authorities

We regularly review our compliance with our Privacy Policy. When we receive formal written complaints, we will contact the person who made the complaint to follow up. We work with the appropriate regulatory authorities, including local data protection authorities, to resolve any complaints regarding the transfer of personal data that we cannot resolve with our users directly.
